### 2 Reduction and/or elimination of staff postitons

**Item Comment:** For FY 10

Texas A&M University-Texarkana implemented a flexible hiring freeze for all positions. Positions will be reviewed and evaluated as to the critical need of the institution. Currently, 5 positions have been permanently frozen. These positions may remain frozen for a minimum of 60 days to an indefinite period. This figure will be fluid as current positions may become open in the future. The services provided by the frozen positions will be reduced or eliminated.

#### For FY 11

The continued hiring freeze will be evaluated on a position basis. With the University in the first year of downward expansion, every position will be critical to this mission. The University will also be transitioning to its new campus and these staffing cuts will result in services being reduced or eliminated for students, staff, faculty and community constituents.

**Item Comment:** For FY 2010:

Five FTE vacant faculty positions will be eliminated. This will likely result in the cancellation of some summer classes which are needed by students to graduate on time. In addition, we will delay the hiring of 2 positions and will not fill 3 faculty positions in which the faculty member will be terminating in May 2010. Summer salaries will be flexible based upon student FTE quotas.

### For FY 2011:

An additional Two FTE faculty positions will be eliminated. With limited salary funds to pay for part-time instructors, 16 to 19 previously offered course sections will be eliminated for each of the two long semesters and approximately 10 summer sections in the first year of downward expansion.
